hereby resolve to submit my personal and biometric data to LLC "Visa Management Service" BIN 1087746305624, TIN 7704680281, legal address: Russian Federation, 119017, Moscow, Maliy Tolmachevskiy lane, 6, bldg. 1 (hereinafter referred to as "Operator of Personal Data") and agree, by my own will and in my interest, that such data be processed on the following terms:

1. The purpose of processing personal and biometric data is the execution of instructions of individuals submitting documents (subjects of personal data) based on a contract in a simple written form with the Operator of personal data and transferring the sets of documents to the Consulate General of the Italian Republic in Moscow or the Consulate General of the Italian Republic in St. Petersburg in order to obtain entry visas for tourist and other purposes of travel to Italy, as well as obtaining the documents from the Operator of Personal Data after completing all processing formalities from the Consulate and transferring them to the applicant.

2. The list of personal data for processing of which the subject of personal data gives its consent is as follows: surname / surname at birth, name, patronymic; date of birth; place of birth; the state of birth; citizenship / citizenship at birth; sex; marital status; for minors: surname, name, patronymic, address and citizenship of the guardian / legal representative; home address; information about registration; phone number; e-mail address; passport data: series, number, issuing authority, date of issue; data of the internal passport; birth certificate data; data of the document of legal staying in the Russian Federation; profession; income; name and address of the place of work / school; work phone; surname and name of the inviting person; the name of the inviting company / organization / institution; name of the hotel; address of the inviting party; phone number, fax number and e-mail address of the inviting party; biometric data: photograph, fingerprints.

3. Consent for processing of personal and biometric data is given for the following actions:
The processing of the above-mentioned personal data will be carried out through the processing of personal data (collection, systematization, accumulation, storage, clarification, updating, changes in use, distribution), transmission (including cross-border transmission), depersonalization, blocking, destruction of personal data. The general description of methods of data processing is provided by the Federal Law No. 152 dated July 27, 2006.

4. The period of validity of the consent of the subject of personal data, as well as the method for its revocation, unless otherwise established by federal law, is as follows: the personal data of the subject shall be stored within the terms established by law. Personal data is destroyed when: personal data processing objectives are achieved; at liquidation or reorganization of LLC "Visa Management Service"; on the basis of a written request from the subject of personal data to stop processing his/her personal data (the Operator of Personal Data will stop processing the personal data within 3 (three) business days and will send the confirmation notification in written form to the subject of personal data within 10 (ten) business days).

The subject, upon written request, is entitled to receive information regarding the processing of his/her personal data (in accordance with clause 4 of Article 14 of Federal Law No. 152 dated July 27, 2006).

I confirm that in accordance with Clause 1, Part 2 of Article 18 of Federal Law No. 152-FZ dated July 27, 2006 "On Personal Data," members of my family and my close relatives, as well as persons who invite me to a foreign country, will be notified by me about the processing of their following personal data: surname, name, patronymic; date of birth; information about kinship ties; contact phone number; contact email address; the actual address of the actual place of residence or place of stay; information on citizenship; name, series and number of the valid identity document.

I confirm that I am aware of the provisions of Federal Law No. 152-FZ dated July 27, 2006 "On Personal Data", and that the rights and responsibilities in the field of personal data protection have been disclosed clearly to me.
