In accordance with the provisions of the article 6 of the Agreement between the European Community and the Russian Federation on the facilitation of the issuance of visas, while applying for visas type 'C', the following categories of applicants are exempt from the visa fee:

- close relatives — spouses, children (including adopted) parents (including custodians), grandparents and grandchildren — of citizens of the European Union and of the Russian Federation legally residing in the territory of the Russian Federation or the Member States;

In both cases it is necessary to provide documents confirming the relationship (birth, marriage certificates etc. as applicable) with person residing in the EU or person holding a valid permit of stay and a copy of the passport or a copy of the residence permit in the EU, respectively.

For the citizens of: Russian Federation, Armenia, Azerbaijan, Republic of Belarus, Georgia and Ukraine (Except Biometric passports) visa fee is not required for the following categories (only applying for "C" category visa):

- close relatives of citizens of the European Union & Swiss Confederation;
- children under the age of 6 at the time of the document submission;
- disabled person (all disability categories with original and copy of certificate of disability) and 1 accompanying person (accompanying person must be of legal age);
- participants of the youth international sports events and accompanying persons;
- for participants in official exchange programmes organised by twin cities.

## For all other country nationals visa fee is not required for the following categories (only applying for "C" category visa):

- close relatives of citizens of the European Union & Swiss Confederation;
- children under the age of 6 at the time of the document submission.

## How and where to pay a visa fee?

Visa fee can be paid online or at the branches of JSC "Bank Intesa". Kindly note that in case of paying visa fee online, it's necessary to visit in person JSC "Bank Intesa" branch office before submission for confirming the payment and getting the receipt . While submitting ddocuments at:

- Moscow, Malyi Tolmachevskii lane, 6, bld. 1 visa fee can be paid in the branch of JSC Bank Intesa located on the premises of Visa application centre;
- Moscow, Kiyevskaya st., est. 2, Commercial and hotel complex "Kievskiy" and
- Moscow, Mytnaya st. 1, bld. 1, office VIP Premium Lounge visa fee can be paid by cash or bank card at the cash desk of the Visa application centre after conclusion of the contract.
